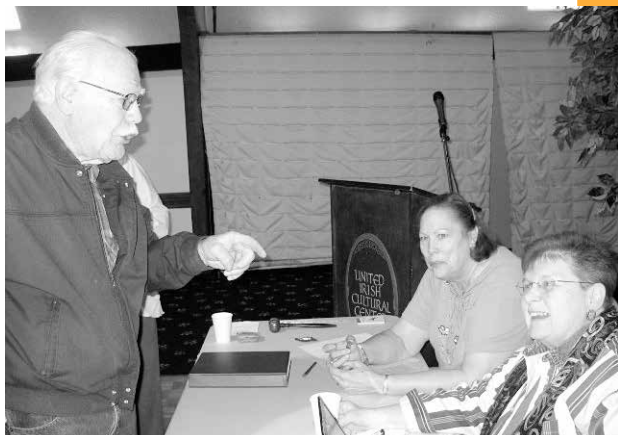
A Unique View of San Francisco

SFERS Investments

Still on Upswing

Plan value increased from 2/28/2013's \$16.7B to 3/29/2013's \$16.9B; and fiscal year to date (FYTD) earnings increased from 10.7% to 12.5%.

Attempt to Influence Banks'

Home Mortgage Lending Practices Fails

On April 10, representatives of SEIU Local 1021, local "Occupy" organizations such as Alliance for Californians for Community Empowerment (ACCE), city employees and retirees, Wells Fargo Bank, the San Francisco Chamber of Commerce, and other interested parties crowded the SFERS Board meeting room. Two motions, initiated by Commissioner Herb Meiberger CFA (elected), related to alleged predatory home mortgage lending practices by three banks that SFERS invests in: Bank of America,

JPMorgan Chase, and Wells Fargo. Both motions were made under SFERS' policies, Levels 1 and 2, and were for *engagement* only, *not divestment*.

Level 1 reduces the power of CEOs/board chairs and supports banks' disclosure/reforms of home lending practices.

Level 2 includes Level 1 provisions, adding outreach to other institutional investors for support, and asks banks for permanent, affordable loan modifications to eligible mortgagees.

Commissioners Driscoll, Makras, Meiberger and Stansbury participated in the discussion and vote. Over 40 attendees spoke from the floor. Wells Fargo representatives denied wrongdoing—absolutely—and pointed to the charitable acts Wells Fargo performs in San Francisco. Public employee representatives reiterated their stance in previous months' SFERS Board meetings: that their members have been subjected to predatory practices and illegal evictions. Individual active and retired employees also added stories of

alleged wrongful treatment by the banks. Finally, in summary, Commissioner Meiberger read messages in support of separation of CEO and Board seats by Chief Investment Officer of CalPers Joseph Dear, and in support of both Levels 1 and 2 by Executive Director of the San Francisco Labor Council Tim Paulson. Commissioner Joe Driscoll, CFA (elected) said he was not convinced, after all arguments and evidence had been presented, that Levels 1 and 2 motions were justified.

Support for Levels 1 and 2 failed for lack of majority vote: Commissioners Meiberger and Stansbury voted "for"; Commissioners Driscoll and Makras "against." No further action was taken.

Protect Our Benefits Report

For Your Immediate Attention!

The Superior Court of San Francisco will hear the Petition for Writ of Mandate, as filed by Protect Our Benefits (POB) on behalf of all retirees, on May 20, in Department 302, San Francisco Superior Court, 400 McAllister St., beginning at 9:30 a.m. It is important for interested retirees to attend the court hearing, which may be called at any time between 9:30 and 11 a.m.

Because the issues presented in the petition will be fully briefed in writing, the hearing may consist of the judge asking each side questions about important issues in the case. The judge may, but is not required to, issue a decision on the day of the hearing.

Protect Our Benefits (POB) filed the action with a specific request

that the court declare invalid the sentence in the Proposition C 2011 charter amendment that prohibits the payment of the Supplemental COLA. The legal basis is that the reduction or elimination of a pension benefit is an impairment of contract.

The invalidation is based on the fact that all pensions—and all of the elements of pensions—are delayed payment for work performed, protected by the contract clauses of the state (Article 1, Sec. 9, CA) and federal (Article 1, Sec. 10, US) constitutions.

The City and County of San Francisco is the respondent in our petition. As the governing board for the City and County of San Francisco, the Board of Supervisors placed the charter amendment on the ballot in 2011, which resulted in the elimination of the supplemental cost of living adjustment unless the

retirement system is "fully funded."

Upon agreement with the city attorney's office, the legal counsel representing the city, they were required to file their *Response to the Petition for Writ of Mandate* on, or before, April 29, 2013. POB will file its Reply to the City's Response on, or before, May 13, 2013.

It is important to note that POB seeks to set aside *only* the one sentence in the charter amendment that prohibits the Supplemental COLA. If the petition is successful, the remainder of the charter amendment, labeled Proposition C, will remain intact.

Health Service Committee Report

New Commissioner

The first item of business was the Proposition C-required approval of the controller's appointee. Executive Director Catherine Dodd recruited Randolph R. Scott, who will take office after Commissioner Zvanski's term ends on May 15. Mr. Scott, who has an impressive resume, will serve for two years. Successive terms will be five years each.

10-County Survey

Calculations for the charter-mandated 10-county survey that sets the employer's minimum monthly contribution rate resulted in a 4.65% increase, from \$534.78 to \$559.65. The charter further defines the setting of premium rates for retirees.

Dental Rates

Since Delta Dental rates are increasing after three years, the board asked the actuaries to work with Delta to improve the retiree dental benefit. It became clear that improving the benefit is impossible at this time since the plan is losing money—the loss ratio is over 100%. The board adopted a two-year rate guarantee that included the Health Insurance Tax of 1.1% requirement, as per the *Patient Protection & Affordable Care Act-PPACA*.

Vision Benefit

After three years with no premium increases, VSP rates will increase by 5.5% (includes a 2% PPACA mandated health insurance tax) and are guaranteed for two years. The current plan (12/24/24) has been operating at a loss, so the increase is necessary. The Vision Buy-Up plan (12/12/12) is scheduled to be available in 2016.

Covered California (PPACA & Exchanges in California)

PPACA mandates the purchase

of health insurance. Exchanges are government-regulated entities intended to facilitate the purchase of health insurance. The greatest challenge will be implementing PPACA in rural areas, such as Tulumne County. The PPACA Health Insurance Tax is imposed on companies offering health benefits and is being passed through to members through rates. Medical rates will also include the excise tax imposed on large employers. PPACA will increase premiums for all benefits, at all levels. HSS expects there will be many questions—along with member confusion—as PPACA is implemented. An informational mailing will be sent out later this year.

The HSS board passed a resolution on health benefits purchasing and data transparency that requests that the Board of Supervisors and the mayor seek passage of legislation to establish full quality and cost transparency, with the goal of reducing rates. Commissioner Fraser cautioned that transparency doesn't always reduce rates, as lower cost providers may discover higher competitor rates and then raise their rates. (CalPERS passed a similar resolution in February.)

Know Where Your Money Goes: Track Your Spending!

If cash seems to disappear from your wallet, now's the time to find out where it's going! Becoming keenly aware of cash flow will help you reduce budgetary waste—and leave more money in your pocket for truly important goals and expenses. There are several good methods you can use to track spending:

- Carry a small notebook (or use your smartphone) to record the details of each purchase you make. At the end of the day, total what you've spent. You'll soon have a good idea of where those \$40 ATM withdrawals really go.
- Keep receipts from each of your purchases and tally them up daily. It won't be absolutely precise if you shop at places that don't give receipts (such as soda machines), but it will be close enough to be revealing.
- Use a debit card for all, or most, of your shopping. Every pur-

chase and cash withdrawal will be noted on your statement. Review it regularly.

- Use expense-tracking software. After monitoring your spending for at least a few weeks, enter the information into a longterm expense tracking system. A few months of doing so and you'll have an accurate picture of where your cash is going.

Only after you know today's spending habits can you make realistic financial decisions to better your future. Need more help tracking? As a benefit of belonging to San Francisco Federal Credit Union, you have access to personal financial counseling at no charge through BALANCE.
