Retirement Committee Report

Plan performance—upward!

Preliminary results as of 4/30/2014: Plan value is another all-time high at \$19.1B, and ten months fiscal year-to-date (FYTD) earnings are 14.6%, handily outstripping the 7.58% actuarial expected earnings for the entire 2013/14 fiscal year. June 30, 2014, the end of this fiscal year, is fast approaching. Will the Plan be 100% funded on the market value of assets by then, permitting our FY 2015/16 supplemental COLA? Stay tuned.

A first step toward purchase of an SFERS headquarters building

On 5/14/2014, the SFERS Board, by unanimous vote, directed staff to pursue and prioritize the purchase of a building in San Francisco for SFERS headquarters, and to report back to the Board within 60 days. Specifically, the Board wants a building in the Civic Center area of at least 50,000 square feet—readily accessible to retirees and active employees—to serve as permanent offices of the Retirement System and the Health Service System. Consideration will be given to include other City departments. During public comment, RECCSF President-elect **Claire Zvanski** said that she had heard discussions for 40 years about buying a new building, and that she is delighted that finally something will be done! (Incidentally, SFERS management read aloud a letter from **Protect Our Benefits** in support of this action. See the Protect Our Benefits column for details.)

Board president and mayoral appointee **Victor Makras**

explained that purchasing a building is likely to be profitable because San Francisco rentals, especially in the Civic Center area, are bound to increase. Mr. Makras cited at least two contributing factors: Firstly, San Francisco expects a large influx of residents/businesses in the coming years, putting pressure on rentals and making land and buildings more valuable; secondly, City government departments are long-term stable tenants.

The search process will not affect SFERS's move to 1145 Market St., which is expected this September.

SFERS Board closed session for "certain" investments

Another unanimous Board decision on 5/14/2014: to close public attendance at board meetings where the purchase or sale of particular pension fund investments are being considered (permitted under California Government Code 54956.81). Executive Director **Jay Huish's** 5/14/2014 staff memo clarifies that "...generally the Retirement Board *could* (emphasis added) enter closed session to consider the purchase or sale of specific stocks, bonds, real assets, and alternative investments." However, under *reporting out* requirements, the Board's actions will be publicly disclosed after "the earlier of the close of the investment transaction or the transfer of pension fund assets for the investment transaction" (also from Jay Huish's 5/14/2014 staff memo).

Investment staff and board members said that, under current open meeting policies, some highly desirable investment opportunities are (and have been) unreachable; that confidentiality in competitive environments

is crucial; and that presenters feel constrained to publicly disclose sensitive details that board members need to know. One commissioner emphasized that the Board is responsible for the financial health of the Fund, which is frequently publicly reported. During public comment, **Jean Thomas** asked that the discussion be deferred until SEIU, as well as other employee and retiree organizations, have a full understanding of the new policy—which was totally unexpected—and that this policy appears to violate the basic tenets of the Sunshine Ordinance, crucial to good government and transparency.

Other Items of Interest

- The Board approved the draft of the Annual Report for fiscal year ended June 30, 2013; contact SFERS administration for availability.
- The fossil fuel divestment update meeting will take place on June 18, at 2 p.m. at 101 Grove, Room 300, unless Supervisor Avalos secures a City Hall location. Call SFERS shortly before the meeting date.

Health Service Committee Report

Blue Shield and retiree dental were the primary issues on the Health Service Board agenda. Blue Shield's 2011 2% profit pledge resulted in a rate refund. The board decided to apply it to rates over three years. This was before Blue Shield became a flex-funded plan.

Additionally, the Accountable Care Organization (ACO) performance resulted in claims savings which also keep the premium costs low. The board also discussed an incentive policy for the ACOs. This profit pledge refund was put into the Stabilization Reserve to be applied to 2014, 2015 and 2016 rates. While this is most significant for active employee rates, there is a direct impact on early retiree rates. The primary reason for this manipulation of rates is to minimize migration between HMO plans.

Blue Shield 2015 plan rates were tentatively adopted, pending the finalization of contract negotiations for active employees. Most contracts involve health plan subsidies that eliminate the charter-mandated 10-county formula. However, it is imperative to maintain the 10-county survey in order to set retiree rates. The charter connects active and retiree rates and sets the minimum employer stipend. The board stated it needed a special May meeting to review rates again before it finalizes rates in June; then the rates are submitted to the Board

of Supervisors. The proposed rate increase for Blue Shield for 2015 is 4%.

There was an encouraging 20% response to the retiree dental survey. The majority (56%) of responses were:

- no change
- exempt preventative care
- change is unaffordable
- \$5 a month would be worth an improvement.

Comments from members were also shared. After extensive deliberation and discussion, the board adopted a rate that exempted diagnostic and preventative care from the \$1,000 maximum. The net result is valued at \$1,200-\$1,500, depending on the cost of two annual cleanings, x-rays, and other diagnostics. Everyone present representing retirees testified that this was the best option, as it gives a benefit im-

provement without a significant rate increase. It was also noted that regular preventive dental care is directly related to good overall health, especially heart health.

The eMerge system shuts down during payroll preparation, and during this period HSS is unable to access files and conduct business; so, the HSS office will open at 9:30 a.m. on alternate Thursdays. For details, visit www.myhss.org.

The Wellness Center celebrates its official grand opening May 19-23. Daily prizes and raffles are planned. Everyone is invited.

Protect Our Benefits

Protect Our Benefits is an independent political action committee which falls under the provisions of the San Francisco Ethics Commission and is not part of RECCSF. The opinions are those of the writer.

Lawsuit Update

The opening brief was filed in the court of appeal during the week of May 12, 2014. The document includes charter sections dating from 1950 that show the voters increasing pension benefits for retired City employees after they retired. The main issue is whether the sentence in Proposition C which adds the requirement of the retirement system being “fully funded” before the supplemental COLA can be implemented is legitimate. Our legal team is asking the

court of appeal to agree with POB that the sentence is *not* legitimate, based on at least four main points. (Please visit POB Web site for details.)

The POB legal team is confident that the court of appeal will scrutinize the issues and the arguments on both sides—and that POB will prevail.

Amicus Briefs

Under California Rules of Court an amicus brief is filed “...within 14 days after appellant’s reply brief is filed or was required to be filed...”

After the opening brief is filed, the City will probably take 60 days to file its response brief. POB’s legal team will then have 20 days to file a reply brief. The applications for amicus briefs will not be filed until 14 days after that—*about 90 days from this week.* The San Francisco

Veteran Police Officers Association, the San Francisco Retired Firefighters, and RECCSF are filing amicus briefs.

Encourage Retirement Board

Protect Our Benefits wrote a letter to Victor Makras, president, San Francisco Employees’ Retirement System Board, stating: “At our regular monthly meeting on May 12, POB voted to support the agenda item discussing and directing staff to identify and procure resources to pursue purchase of a **sole building** in San Francisco for the SFERS headquarters with the intent that HSS be housed in the building.”

Future Planning

POB continues to develop and implement a strategic plan to educate the public, decision-makers, and elected officials about protecting our benefits. This entails a combination of City Hall lobbying, community organizing, and social media outreach.

What to Do If Your Wallet or Purse is Missing

Losing your wallet or purse can leave you feeling completely exposed. Here's how to take back some peace of mind.

- **File a police report.** This will help with later steps, like getting fraudulent charges reversed or getting incorrect information removed from your credit report.
- **Call card issuers, financial institutions and insurance companies.** The faster you do

this, the better, since reporting quickly could eliminate or reduce your liability for fraudulent charges or activity.

- **Contact the DMV and Social Security.** Report your license, and, if necessary, your Social Security card as missing and get replacements.
- For membership or library cards, contact the issuer and ask that the account be closed and re-opened. Think of all memberships; like gyms, alumni groups, fraternal organizations, and service organizations.

- Monitor your accounts and your credit reports closely. If you believe you may have been the victim of identity theft, you are entitled to an extra copy of each of your three credit reports for free. Consider putting a fraud alert or security freeze on your credit file.
