San Francisco Health Service System Report

There have been important developments in California and nationally, both impacting retirees. Prescription drug prices have become one of the biggest factors driving up health coverage premiums. Just this week, California Governor Jerry Brown took a bold step on behalf of the public by signing the most comprehensive drug price transparency bill in the nation into law. California continues to be a leader in setting legal precedent with SB-17, a bill that gives Californians the right to know how and why their prescription medications are priced by pharmaceutical companies.

Specifically, the new law requires pharmaceutical companies to give state and health insurers 60-day notice anytime they plan to raise medication prices for consumers by 16% or higher over a two-year period.

The unparalleled bill goes further because, in addition to mandatory notification, companies must provide a justification for the increased cost. The law also requires that health plans and insurers file annual reports that outline how drug costs affect healthcare premiums in California. This is a milestone for consumers and great news for healthcare advocates—and transparency in pricing—as evidenced by the fact that drug lobbyists spent nearly \$17 million opposing it.

The Health Service System was a strong and early proponent of SB-17, and formally recommended support of

This meeting was most interesting for the information it revealed to members. The first item of business was the Implementation Plan for Absolute Return; in other words, the implementation plan for increasing the investments in **hedge funds from 5%** (\$1 billion) to 15% that was approved at the September meeting—which is **approximately \$3.5 billion of the \$23.3 billion** portfolio (fund). Blackrock is the portfolio manager for the Absolute Return.

During this discussion, Commissioner Makras raised the issue of investment transparency. He stated that he had requested a list of investments, and that his request was not addressed or provided by staff. He stated that he could not support the recommendations without full disclosure of investments. It was reported that David Franci, managing director of Absolute Return (SFERS), and Brad Rudner, managing director, co-head of North American Institutional Client Relations of Blackstone Alternative Asset Management, would provide the overview of the implementation plan for the increased allocation to the Absolute Return program. This started a discussion about abdicating the responsibility of investment decisions to staff (which compromises the fiduciary responsibility of commissioners who are legally responsible). Director Huish stated that commissioners could get the information on a confidential basis, but he was not aware of any requests. Commissioner Bridges stated that she had supported the 5%, but was not in favor of the 15% allocation, and concurred

that she wanted additional information about the proposed investments. Staff continued to argue that Mr. Franci and Mr. Rudner were most knowledgeable and competent to make these investment decisions, negotiate discounted fee agreements, and then report to the commission during its investment deliberations. It was further argued that revealing investment lists would compromise the ability of Blackstone to make the best hedge fund investments and to negotiate lower fees. These hedge funds are not involved in publicly disclosed investment strategies. Therefore, the investment lists cannot be disclosed to anyone, except to commissioners who request it—and only on a confidential basis.

An updated Investment Policy Statement was presented to the commission as a "living document." This means that concerns of commissioners could be addressed in the future, but the new phrases regarding investments would be approved now. Commissioner Makras pointed out—and objected to—the section that abrogated investment decisions to staff instead of commissioners. Additionally, the ESG (Environmental, Social and Governance) values statement was modified to apply to only publicly traded investment equities. This came as a major surprise to member representatives present, who believed that investment policies passed by the board applied to all investments. It was clarified through this updated policy statement that **divestments and investment policy decisions** involving Sudan, tobacco, thermal coal, and fossil fuels **applied only to the publicly traded equities**, and not to the privately traded equities, such as hedge funds and other private investment portfolios. Commissioner Makras asked how many private investment portfolios included investments in these otherwise prohibited investments, such as thermal coal and fossil fuels. It was disclosed that there were such investments since the policy only applied to publicly traded equities.

The last most significant issue presented was Executive Director Jay Huish's update on the grand jury recommendations to change the composition of the retirement board. The Board of Supervisors has indicated that a charter change is being researched and composed for 2018 to add three members of the public to the Retirement Board, and bring the total up to ten members since the grand jury report stated that public oversight of the functions of the Retirement Board would be prudent, and prevent future benefits (such as COLAS) from being indiscriminately granted.

the bill to the State Legislation Committee back in February, 2017; and namely for the bill's ability to help purchasers of healthcare predict and manage costs for new medication and existing drugs.

In other news, the Centers for Medicare and Medicaid Services (CMS) will begin issuing new Medicare cards with new "Medicare Beneficiary Identifier" numbers in place of social security numbers, in order to protect consumers from identity theft and fraud. The new Medicare cards will be sent to 60 million beneficiaries starting in April 2018, and continue into 2019. CMS will randomize card mailing by geographic region.

According to CMS, Medicare beneficiaries do not need to do anything, except to remain prudent about protecting

SFERS v. CCSF

The City and County of San Francisco requested a 60-day extension to file its response brief, which is now due Oct. 28—or sooner. As soon as CCSF responds, SFERS will have the opportunity to submit a reply brief. (I know it can get confusing!)

Within 14 days after CCSF's reply brief, we, the POB, can file an amicus brief. Best Practices for Personal Safety

(Abridged Information from SF Safe)

To maximize your personal safety, take a minute to plan and prepare for safety before leaving home.

Limit your valuables by carrying only what you need for the day. If you must carry large sums of money or personal items, consider placing them close to your body.

Never leave valuables unattended.

When on the street be alert and aware at all times. Walk with confidence and purpose. Most victims will be targeted when they appear not to be paying attention to their surroundings.

A handbag should not be strapped across your body. It should be carried under the arm and released when grabbed. This will prevent you being pulled to the ground in an assault.

Have your cell phone easily accessible in case you need to call 911. Keep your cell phone fully charged at all times.



It is a good practice to let someone know your itinerary and the time you are expected to return.

There is safety in numbers. Make every effort to walk with others when leaving a building or location. Walk well-travelled, well-lit streets. Do not take short cuts through parking lots or alleys.

Get to know the stores and public buildings along your walking route.

Digital music players (and iPhones) are a common target of thieves and robbers. Be wise about where you can choose to use it in public. Wearing your headphones or ear buds greatly reduce your ability to hear and distracts you from potential dangers.

If taking public transportation, have your money or Clipper Card ready. Do not fumble. Never discuss personal information (money, account number, etc) near strangers. There is a good chance that someone could overhear and act on the information.

ATM transactions should be made inside a store or at an ATM that is well-lit and visible. Shield the keypad as you enter your PIN. Have your card ready and do not count or display your money. Put your money away in a pocket or purse immediately. Take your receipt with you.

Trust your instincts. If you feel uncomfortable or threatened see help immediately. A whistle is a great device to carry.

Protect your vehicle from theft. Always lock your doors and glove box. Never hide a spare key on your car. Never leave valuables (GPS, phones, laptop computers, purses, coins, jewelry, wallets etc.) unattended in your car. When possible, park your car in well-lit areas with lots of traffic.

How to Protect your Identity after a Major Data Breach

How do you know if your personal information was stolen? In the Equifax data breach of September 2017, hackers reportedly accessed up to 143 million Americans' social security numbers, birth dates, credit card numbers, and more pieces of sensitive information.

Are you curious as to whether or not you're one of the victims? Don't wait until you're hit with a major bill for un-recognizable purchases made in your name. Here are some effective ways to make sure that you're safe:

Check your credit report

Every consumer is allowed to access a free copy of their credit report annually at *annualcreditreport.com*. Your report will show information about you from the three major credit reporting agencies; Experian, Equifax, and TransUnion. Review everything. You'll want to look for unidentified accounts or loans in your name, and inaccurate information. (These are signs that someone has stolen your identity).

Place a freeze on your files

When you freeze your credit files, you make it impossible for new accounts to be opened in your name. Of course, this could be problematic for your own finances, so only take this step if you feel confident that someone is trying to abuse your identity. Also, keep in mind that a credit freeze doesn't prevent charges from occurring on existing accounts.

Sign up for fraud alerts

Think you might've been victimized but don't want to choose the nuclear option of a credit freeze? Place fraud alerts on your credit files. With fraud alerts, creditors are required to verify that anyone trying to open a line of credit in your name is truly you.

Visit Equifax's website at *Equifax.com*. To help victims of the data breach, Equifax created a dedicated website. Whether or not you were impacted by the hack, you can sign up for free credit monitoring for a year. For anyone who suspects that their finances are vulnerable, it might be

a good way to maintain peace of mind.
