## Retirement Committee Report

While investment rates remain fairly low in many categories, CIO Bill Coaker reports that the SFERS fund has now reached \$27 billion as of Nov. 30, 2019. While the board has been moving many investments from public equity to private equity, it is ironic that public equity investments are making the highest returns in the past few months, and quarter. Most assets are achieving returns below 1% at this point, but public equity is returning 6% for the quarter and 3.3% in November. The fund's total return for November was 1.46%. Approximately 55% of assets are in public and private equities. SFERS remains in the top 1% of small public pension plans nationally. Coaker also points out that trade issues are impacting investments, especially the potential new tariffs on imports from France, Brazil, and Argentina.

The board is updating and making changes to its **Investment Policy Statement** which provides the framework for the management of the system assets. It addresses the **goals** of the investment program, the investment **beliefs** for managing plan assets, the **policies and procedures** for the management of the investments, the strategic asset allocations, **rebalancing** procedures and asset class definitions, and, finally, the **duties** of responsible parties.

Actuarial Services Coordinator Janet Brazelton presented the **Supplemental COLA Analysis as of July 1, 2019,** by Cheiron. The findings are that there are excess earnings, as defined by Charter A8.526-3, and provides that

Currently, Kaiser contracts with lay agencies, but is actively seeking a contract with a new agency, with the goal of increasing services. It was agreed that a progress report would be released every three months. (The next report is scheduled to be released by March 2020.)

Kaiser staff reported that clients requiring wheelchairs may use current lay transportation services. The client/ patient would be picked up the curb near their address. The driver would assist them into the vehicle, place the wheelchair into the trunk, and then transport the client to the appointment location.

Health Service System board members are expected to complete responses by Jan. 15, 2020. The Governance Committee will prepare a report and present results in closed session to the board.

An open enrollment report was presented by Chief Operating Officer Mitchell Griggs. Enterprise Systems & Analytics (ESA) team members helped members to enroll online. We may wish to investigate how to participate in training sessions for those who prefer to use the computer/smart phone.

Another report given by Kaiser Hospital Assistant Physician in Chief Dawn Ogawa, M.D., updated us on enhancements to improve followup on chronic case management. Electronic health record data is more patient-oriented,

while they are insufficient to provide the maximum increase, they are sufficient to provide an increase of three percent (3.0%) less the Basic COLA (2%) to the post '96 retirees. As the Retirement System is not fully funded, no supplemental COLA can be paid to members who retired before Nov. 6, 1996. That means that **post '96 retirees** will receive the **retroactive 1% from July 1, 2019** in the payment sent at the end of February, and the full 3% COLA (1% supplemental COLA plus 2% Basic COLA) will then be calculated into member stipends going forward.

The board issued its **2020 retirement board meeting** calendar. We noted that it is always ambitious, so it's helpful to double-check the website for possible updated committee meeting notices.

An Investment Committee meeting is scheduled for Jan. 15 that will focus on science, technology and innovations, plus asset allocations

Lastly, there was an announcement of a **board election** several months ago. The seat held by Brian Stansbury was up for election. No other candidate applied, and Brian submitted the proper candidate forms with valid signatures to qualify to run for the position—which runs through Feb. 20, 2025. Per the charter, Brian was automatically re-elected to the seat since there was no opposition. (That saved the system approximately \$75,000 in election costs.)

and available to the medical team of dieticians, nurses, medical assistants, etc.

All efforts are being made to coordinate high-risk care, and to prepare for discharge planning, with a 24-hour followup after discharge.

Another complex issue: Brown & Toland Medical Group, due to changes in primary care providers, transitioned on Dec. 31, 2019 into a new Sutter Medical Group. The 49 members in Trio are not able to access these physicians and will need to choose new primary care providers.

BTP and Sutter are working on notifying clients/patients of changes. Referrals are not expected to be disrupted.

## Notification of RECCSF Dues increase, as of 1/1/20

During the past several years, the notion of implementing an annual dues increase, proposed by RECCSF Treasurer George Lau in order to bolster shrinking RECCSF financial resources, has been discussed at multiple RECCSF board meetings. Your executive board finally passed the motion at its Aug. 20 board meeting to bring this to the membership for a vote. The Board made this decision in accordance with the following constitutional requirements.

#### **RECCSF Constitution:**

Article 7, Section 1a: Notice was given in our September, October, November and December publication, *News and Views*, particularly stating, "The motion is to increase annual membership dues by \$20, raising annual dues from \$48 to \$68."

#### Article 7 section 1B

At the Aug. 20 RECCSF board meeting, the RECCSF Executive Board, in accordance with constitution and bylaw requirements, passed a motion to bring the increase of annual dues to the membership for a vote at its Wednesday, Dec. 11 General Membership Meeting.

#### Article 3, section 3

Requires a quorum of 50 RECCSF members in order to take a vote.

#### Article 7 section 1C

At the Dec. 11 General Membership Meeting, the motion was read, seconded and discussed, and a vote was taken that required passage by two thirds of the members present. RECCSF President Mary Anne McGuire-Hickey validated that this quorum requirement was met.

I was born in Alameda, California. Because of my Dad's work, we lived nine years in Vermont, and another nine years near Cape Canaveral, Florida.


