## Retirement Committee Report

The hot topics of the meeting revolved around the issuance of two very critical requests for proposal (RFP). The first RFP is for general investment consulting services. The consultant would serve as advisors to the fund (including both board and staff) on total fund investment policy and asset allocation, performance reporting, and—finally—training, education, and client relationship. The consultants would attend monthly board meetings and provide special education and training to the board. The second RFP is for public markets investment consulting services, which includes matters related to strategic and tactical investment planning, market research and investment due diligence for its public markets portfolios. The responses are due Dec. 15.

According to new CEO/CIO Alison Romano, while this has been one of the worst years in its 40-year history, our fund seems to still be performing ahead of its peers and managing to remain at 100% funding with assets of \$32.5 billion. Year-to-date earnings are -11.41%. The fiscal year-to-date percentage is -2.34. There will be no supplemental COLA. It is important to point out that returns on public equity were over (minus) -30% but its saving grace came from real assets with a positive return of 15.66. Private credit also brought 3.99%. The market remains quite vola-

tile in both earnings and expectations and no change is foreseeable. It was also stated that many are earning on inflation and not increased product sales. Market fluctuations are a daily occurrence. This is quite frustrating for everyone!

The annual risk management report was provided, which evaluates key risk drivers, highlights current and historical exposures and concentrations, examines adjusted performance and whether SFERS was compensated for taking these risks, and concludes with a review of relevant stress tests and scenario analyses. SFERS primary investments remain in technology, China, biotech/health care and active management. Staff maintains conviction and confidence around these active risks despite the challenges of fiscal year ending June 30, 2022.

Lastly, the Deputy City Attorney reported on a proposed Special Needs Trust Ordinance for active employees. It would allow active employees to designate a beneficiary for an adult dependent child to receive a retirement continuance that would not impact that dependent's qualification for any type of public assistance programs such as housing. We will inquire if it would be applicable to current special needs adult dependents of retirees.

adjustment (COLA) to their pensions).

We also voted in favor of encouraging a "yes" vote on Proposition "O," an additional parcel tax for City College of San Francisco. (I am personally in favor of that proposition since I am a City College alumnus.) The parcel tax will not affect properties in which a person of at least 65 years of age before July 1 of the fiscal year has an ownership interest and lives at the property.

#### What We Do


The San Francisco Health Service System executes all process phases related to benefit operations and administration of non-pension benefits (including health, dental and vision) and other voluntary benefits.


